TERMS AND CONDITIONS OF TRADING

- A. Payment is due on or before the 30th day of the month after the issue date of the relevant invoice.
- B. Should there be any default in the above payment terms, all monies owing by applicant to *Inscribe Australia Pty Ltd* shall become immediately due and payable
- C. *Inscribe Australia Pty Ltd* reserves the right to charge interest at 5% p.a .on all monies over 120 days
- D. All expenses, costs or disbursements incurred in recovering or attempting to recover any outstanding monies including debt collection fee and solicitors cost will be paid by applicant.
- E. *Inscribe Australia Pty Ltd* reserves the right to withhold the supply of goods and services at any time without notice to applicant. Applicant will advise *Inscribe Australia Pty Ltd* of all material changes in name and or financial status, which may result in the need to complete an additional application for commercial credit.
- F. If this application is approved, a fixed credit limit will be determined by *Inscribe Australia Pty Ltd*. Should the account exceed this limit, *Inscribe Australia Pty Ltd* reserves the right to withhold the supply of goods and services without notice.
- G. Unless otherwise specified in writing by *Inscribe Australia Pty Ltd* the applicant shall take delivery of the goods at the applicant's nominated delivery address. The risk in respect of the goods, other than actual damage caused by *Inscribe Australia Pty Ltd* shall pass to the applicant upon such delivery.
- H. If applicant is a trustee, the directors warrant that they have the authority and power to enter into this agreement and personally guarantee the performance of all of the trust's obligations under this agreement.

Any dispute or action in relation to these terms and conditions of trading shall be subject to the absolute jurisdiction of the laws of the state of incorporation of *Inscribe Australia Pty Ltd* and these terms and conditions of trading shall be binding upon applicant, its successors, executor administrators and permitted assigns and shall incur to the benefit of *Inscribe Australia Pty Ltd* its successors and assigns.
